



## **Syphilis Cases on the Rise in Ohio**

Recent alerts from both the [Centers for Disease Control and Prevention](#) (CDC) and the [American Academy of Pediatrics](#) (AAP) underscore a concerning national surge in congenital syphilis cases, including in Ohio. **Total syphilis cases in the state have grown by 276%, climbing from 1,923 cases in 2018 to 5,306 cases in 2021.**

***Congenital Syphilis (CS) cases in Ohio have increased from 22 cases in 2018 to 93 cases in 2022, a spike of 423%.***

The implications of congenital syphilis are severe, potentially leading to a spectrum of medical conditions such as low birth weight, long bone deformities, developmental delays, prematurity, miscarriage, stillbirth and tragically, death.

“There are some key steps that healthcare providers can take to help reverse rising syphilis cases in Ohio,” said Ohio Department of Health (ODH) Director Bruce Vanderhoff, M.D., MBA. **“Implement third trimester screening for syphilis for pregnant individuals as a standard of care to prevent congenital syphilis.”** While Ohio law mandates syphilis screening at the first prenatal visit, it may not be sufficient for those at increased risk. *It is recommended that pregnant individuals be screened again at 28 weeks’ gestation to identify and treat syphilis prior to delivery to prevent congenital syphilis, and a final syphilis screening should be conducted at delivery.*
